The proposed 2015-2016 Bainbridge-Guilford spending plan includes several opportunities for our students to grow and achieve while balancing the long term needs of our community and our District facilities. With a projected state aid increase of just over \$600,000 we are proposing enhancements to our student programming that will build upon our current strengths. This plan proposes a 1% tax levy increase, which is less than half of our tax levy cap of 2.1%. By including this modest tax increase we are hoping to stabilize tax rates and avoid large spikes and valleys over the next several years.

Along with our proposal to continue our propane bus replacement plan, we are also seeking approval for a \$1.5 million capital reserve that we can use to offset the local share of future capital projects. With the change in our health insurance plan for all of our employee groups this year we will receive a refund from our previous health insurance consortium of nearly \$1 million. It is our hope that with your support we will be able to re-invest this money into our facilities and protect our investment in our buildings and grounds.

The goal of the Bainbridge-Guilford Board of Education and our administrative team is to provide the most effective educational program for our students possible within the financial realities of our community and our state. This commitment is finally paying off as we anticipate our first three students to graduate with an Associate's Degree this May from TC-3 and we have our first round of seniors to complete our Machinist Training Program. The additional counseling support at our elementary schools has had a positive impact on our students through our ability to work with students on skills and plans prior to crisis. Our elementary computer/STEM (Science, Technology, Engineering, Math) program is providing our students with a vision of the true joys of learning; joys that our state's focus on the Common Core and state testing just cannot provide.

Through change can come growth and it is a truly an exciting time in our schools. We will be starting the 2015-2016 school year with a new business official, two new principals, and a new structure for leading special education services. Though we are saddened by the loss of our great leadership team, we are looking forward to the opportunities that change provides.

As your superintendent, I thank you for your patience and support as we worked through our fiscal challenges. It is our belief that the proposed spending plan enclosed within continues and enhances our strong student programs while providing an effective and efficient management plan for District operations. We look forward to your comments and thoughts at the budget hearing on Tuesday, May 12th.

OVERVIEW OF PROPOSED PROGRAM CHANGES

In developing the proposed budget, the district was able to retain all current programs and positions. Additionally, the district may be able to restore or enhance some programs that were eliminated or diminished over the last few years as the district dealt with the impact of the "Gap Elimination Adjustment" also known as the "GEA".

The overall budget reflects an increase of 2.76% in estimated total expenditures next year.

The table below outlines several program changes that may be reflected in the proposed budget. Please check our web site www.bgcsd.org for updates.

Elementary	The possible addition of up to two elementary Teaching Assistant positions to support our students with disabilities and students who are at risk.
High School	The restoration of up to two Teaching positions to address student discipline, reduce class size, potentially increase student electives and/or provide supervision and a point of contact for our students enrolled in online college courses.
Special Education	The addition of one School Psychologist to enhance support for students with disabilities and to provide assistance to the building principals for managing the special education program.







HOW WILL THE BUDGET AFFECT MY TAXES?

The calculated Tax Levy Limit (Tax Cap) for our school district is 2.1% for the 2015-16 school year. The proposed budget adopted by the Board of Education results in a tax levy increase that is 1.1%, below the cap. Therefore, qualifying district residents may be eligible for the new Property Tax Freeze Credit. This new legislation effectively freezes property taxes on the primary residences of homeowners with annual incomes at or less than \$500,000 in school districts that stay within the property tax cap and develop and implement a Government Efficiency Plan which B-G has accomplished through the change in our health insurance plan.

The chart below is intended to show an estimate of projected tax increases for homes of different assessed values. These are the estimated amounts prior to any refund by the state for qualifying residential properties under the state Property Tax Freeze program.

Actual tax rates are affected by many factors beyond the school district's control such as Assessed Values, State Equalization Rates, and STAR Exemptions. Actual tax rates will not be set until sometime in August when the state finalizes equalization rates for each of our district's ten townships. The following chart simply displays the amount of a 1.0% increase on varying levels of hypothetical assessed values at Full Market Value.







Proposed School Budget

Residents will have the opportunity to vote on the proposed school budget as outlined in this document. An opportunity to learn more about the proposed budget will be provided at our Public Budget Hearing which will be held in the High School Auditorium on Tuesday, May 12, 2015 starting at 7:00 PM. In addition to the Public Hearing, please do not hesitate to contact Superintendent Dr. Donald Wheeler at 967-6321 if you have budget questions.

Proposition to Finance School Bus Purchases

Voters will be presented with a proposition to borrow an amount not to exceed \$284,000 for the replacement of three school buses. The district intends to finance the buses over a period of five years with a Bond Anticipation Note. The principal and interest payments are eligible for Transportation Aid from New York State. The replacement of these vehicles will help the school district to maintain a cost effective and safe fleet for the children that we transport throughout our 100 square mile school district.

Proposition to Establish a Capital Reserve Fund

The Board of Education will ask for approval to establish a capital reserve fund with a maximum amount of \$1.5 million to pay for the cost of improvements to, or reconstruction of our buildings and facilities and the purchase of equipment.

The District will be receiving a refund of approximately \$1 million from the DCMO BOCES Health Insurance Consortium due to our change in health insurance plans for the 2014-15 school year. We are proposing establishing this reserve to use this refund money to offset the local portion of any proposed upcoming projects.

Board of Education Candidates

There are three Board of Education terms that will expire on June 30, 2015. The following individuals have submitted petitions to fill the expiring seats on the Board of Education. 





These expenditures include amounts for instruction of students with disabilities in a general-education setting. District expenditures, such as transportation, debt service and district-wide administration are not included.

The pupil count for General Education is K-12 average daily membership plus K-12 pupils for whom the district pays tuition to another school district. This number represents all pupils, including those classified as having disabilities and those not classified, excluding only students with disabilities placed out of district. Pupils resident in the district but attending a charter school are included. For districts in which a county jail is located, this number includes incarcerated youth to whom the district must provide an education program.

Instructional Expenditures for Special Education are K-12 expenditures for students with disabilities (including summer special education expenditures) plus a proration of building-level administrative and instructional support expenditures. District expenditures, such as transportation, debt service and district-wide administration are not

included.

The pupil count for Special Education is a count of K-12 students with disabilities for the 2012-13 school year plus students for whom the district receives tuition from another district plus students for whom the district pays tuition to another district. Students attending the State schools at Rome and Batavia, private placements and out-of-state placements are included.

Instructional Expenditures Per Pupil is the simple arithmetic ratio of Instructional Expenditures to Pupils. The total cost of instruction for students with disabilities may include both general- and special-education expenditures. Special-education services provided in the general-education classroom may benefit students not classified as having disabilities.






