SUMMARY & BACKGROUND

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. The first portion of ARP-ESSER Funds was awarded to states on March 24, 2021, and 60 days from that day is May 24, 2021. The U.S. Department of Education (USDE) has taken the position that an SEA makes allocations when it authorizes the LEA to begin to obligate funds in accordance with its needs. Upon receipt of such notice, LEAs were able to begin obligating their allocation of 90% base ARP-ESSER funds.

ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. *The B-G District established a Re-Opening committee in June of 2020. This committee has regular meetings to keep the school community apprised of the most recent updates, circumstances, and needs of the district. This committee will continue to serve during implementation of the ARP-ESSER grant for the purpose of involving all stakeholders and ensuring that the funds are being used to implement the plan and meet the needs of our students. The committee will meet at a minimum of once every semester, but meetings are called more often, monthly, if needs arise. *The B-G administrative team met with each area/department to discuss needs due to COVID-19 and prioritize use of funds. The admin team will revisit with each department each semester throughout the implementation of the grant.

A survey was created and put on the school website. All community members were invited to complete the survey to gather input from the entire school community regarding the best use of funds. Future surveys will be conducted in the same fashion throughout the implementation of the

In order to safely open and operate the B-G schools for in-person learning and implement prevention and mitigation strategies consistent with the most recent CDC guidance the B-G district will:

- *Hire additional .6 nurse
- *Purchase additional cleaning equipment and sanitation supplies
- *Purchase necessary furniture for individual student and staff usage that may be efficiently cleaned
- 4. In the space provided below, please describe the data that the LEA will use to identify student needs and monitor student progress as a result of planned interventions and supports.

The B-G district will use triangulated data gathered from baseline benchmark assessments, teacher assessments, and any state assessments available. All students K-8 will have benchmark assessments three times a year, regularly progress monitoring assessments, and summative assessments. Interventions and supports will be adjusted based on data gathered.

At B-G we have several teams that collaborate to plan interventions and supports to address student needs. We have DAT, our district academic team which coordinates curriculum and establishes protocols for interventions to meet student needs. In response to COVID-19 we have planned to provide RtI interventions based on benchmark testing and progress monitoring. This data will be gathered from our newly implemented iReady program, our Wonders program, and NYS ELA and Math modules assessments. We assess all students and determine which skill areas need to be included in our interventions. With this grant, we were able to hire more RtI staff to provide more interventions to all students. We will utilize our SSTs (Student Support Teams) to address specific students with individual intervention needs. These teams include all special area teachers, including counselors, so we may address all areas, academic, social, and emotion. SEL interventions are provided such as adult mentors, check-up programs, relationship building with a 2 for 10 program, positive behavior interventions, and responsive classroom strategies. Tier 1 interventions will be adjustments to grade level curriculum based on data discussed above that determined where students are currently at. Tier 2 and 3 interventions will be provided as push-in and pull-out small groups with increasing frequency to provide students with support to reach grade level. We are working toward utilizing our intervention block in our schedule to ensure that every student is instructed at their level during this time. This time also allows counseling and SEL lessons to occur for all students. We will progress monitor students weekly, bi-weekly, or monthly depending on their tier group and provide skill-based interventions accordingly. Students needing further support will be addressed during our SST meetings and referred for more specialized interventions as needed.

*Hiring an additional RtI teacher to diagnose student academic instructional gaps and provide targeted interventions to help students reach grade level.

- *Purchasing supplies for RtI interventionists, such as the iReady program to help with screening, diagnostic and progress monitoring assessments to improve student growth and achievement.

The B-G district will use the remaining funds to:

- *Purchase radios and hire a .5 SRO to improve coordinated responses in order to prevent, prepare for, and respond to COVID-19
- *Hire an additional .6 nurse to respond to COVID-19 health and safety issues
- *Provide stipends for staff charged with accurate and timely grant management
- *Purchase cleaning equipment, such as vacuum cleaners, washer/dryers, and cleaning supplies to prevent, prepare for and respond to COVID-19
- *Purchase promethean boards to aid instruction and interaction between students and classroom teachers
- *Hire additional teachers and aides in all buildings to meet students' academic needs and provide differentiated instruction during in repsonse to COVID-19
- *Purchase air purifying machines to improve the indoor air quality by filtering and purifying the air in classrooms and school offices.
- *Purchase individual student and staff desks and chairs to meet CDC social distancing guidance and prevent transmission of the COVID-19 virus as much as possible.

The B-G district will continually monitor that the interventions being implemented are responsive to our students by continually assessing student academic needs, student growth and achievement, and student social/emotional/mental health. At B-G we have a multitude of academic PLC's, department teams, student support teams, and administrative teams that regularly meet to ensure our interventions are in line with student needs. The B-G school district primarily serves low-income families and children with disabilities. We do not have ELL students, students of color, students experiencing homelessness, children in foster care, or migratory students.

Our low-income families make up about 50% of our student body. Using grant funds, we have increased our RtI program by hiring additional teachers and aides to provide academic and SEL support to students. These staff members will provide interventions to students in accordance with our RtI program and work with both our DAT and SST programs as described in question #4 above.
